



## LIMITED WARRANTY

**VEGAS MICRO** warrants that the new hardware it sells will remain in good working order free from defects in materials and workmanship under normal use for one year from the date of purchase then the manufacturer's warranty beyond that point. The purchase of a newly constructed computer system will have a parts warranty period of one year from the date of delivery and a one-year warranty on labor unless otherwise stated. Some specific items are warranted by the manufacturer only. VEGAS MICRO will cover all new video monitors, scanners and ups units for 30 days from date of purchase, and then the manufacturer's warranty will take over, whether purchased with a new computer or sold separately. Notebooks, brand name computers and printers will be covered by manufacturer's warranty only. **VEGAS MICRO** will during the warranty period, repair or replace any product at its own discretion. All repaired parts retained by **VEGAS MICRO** become the property of **VEGAS MICRO**. All replacement parts are warranted for 30 days or for the remainder of the original warranty, whichever is longer. This warranty is offered only to the original purchaser and is not transferable.

### **Exceptions:**

This warranty is voidable by **VEGAS MICRO** if the following damage occurs: The hardware is damaged as a result of accident, misuse, abuse, misapplication, unauthorized maintenance, modification, attachments or alterations, acts of God, use of equipment for purposes not otherwise intended for the hardware.
